Twenty-six businesses were discharged [from recovering their money due from Art Smart aka Annie Schmitt] in Federal Court [United States Bankruptcy Case#94-1253] the first week of September [1994].

Many Gay and Gay-friendly businesses lost thousands of dollars and we found doing business with her was insulting and a disservice to people advertising in the [1994 Tucson Pride Commemorative Program], who may have been burned.
